<p>Overhears can be an extremely useful tool in certain felony investigations. Yet they are often under-utilized, due to uncertainty about the various processes involved. This class will provide officers with:</p> <ul style="list-style-type: none"><li>✓ A thorough understanding of the law</li><li>✓ How each part of the law is properly documented on the required forms</li><li>✓ What equipment to use</li><li>✓ Proper instructions are to give to cooperating witnesses</li></ul> <p>Documents will be available that can be used as a starting point to create their agency's own documents according to their State's Attorney's preferences. Attendees will also listen to actual overhears that led to successful prosecutions, as well as unsuccessful overhears.</p>
