### Course Description

This class will cover a myriad of topics regarding sovereign citizen ideologies and how they relate to law enforcement. Sovereign citizens are a type of anti-government extremist that believes the federal government is illegitimate and that they are “freemen” outside the control of its authority. It is estimated that there are several hundred thousand such individuals in the US. There is also overlap between sovereign citizens and radical militia—who fear authorities intend to confiscate weapons of US citizens.

In the past several years, sovereign citizens have increasingly been involved in criminal activities nationwide, including fraud as well as threats and violence against government officials, especially law enforcement. Of particular concern is that such individuals may launch a large-scale attack on law enforcement. Officer safety must also be considered as it relates to traffic stops, calls for service, and interactions with the public.

### Course Objectives

This program will enable participants to: 1) Describe sovereign citizen ideology and address why it is important for law enforcement; 2) Provide historical context, describe previous leadership/principal figures, and trends in the sovereign citizen movement; 3) Comprehend the current structure of the sovereign citizen movement, their modes of radicalization and recruitment, and their implications; 4) Describe who participates in the sovereign citizen movement; 5) Describe sovereign citizen general tactics and activities; 6) Articulate sovereign citizen threats against law enforcement and government officials; 7) Highlight sovereign citizen threats against law enforcement and government officials; and 8) Articulate the manifold responses to sovereign citizen threats in the United States.

### Instructor

Dean C. Alexander is Director of the Homeland Security Research Program and a Professor in Homeland Security at the School of Law Enforcement & Justice Administration at Western Illinois University. His expertise includes terrorism, security, and legal issues. He has lectured in 10 countries, including officials at North Atlantic Treaty Organization, US State Department, and National Intelligence University. He has also worked as a consultant to the World Bank and homeland security firms.
