| <p>Illinois Public Act 94-103 amends the Illinois Police Training Act. This Act (50ILCS 710/2.5) provides for "Annual Range Qualification." The annual range qualification for all peace officers shall consist of range fire approved by the Illinois Law Enforcement Training & Standards Board (ILETSB). The course of fire approved by ILETSB will be used for this qualification. Successful completion of this course also satisfies the training mandate on <i>Use of Force</i>.</p> | | | | | | |
