### Course Description

This class is intended for police officers who have been assigned to enforce liquor law enforcement and age compliance enforcement for tobacco and liquor sales. It is an advanced-level class that goes beyond the uniformed patrol officer "bar check walk-through" and focuses on specific liquor license inspection regulations and procedures. It will focus on the inspection of by-the-drink liquor establishments (taverns) for compliance with state and local regulations governing licensing, signage, restricted sales, advertising, sanitation, and prohibited practices. Special license inspections for seasonal festivals and one-time/special liquor events will also be discussed. Standardized documentation of violations that comply with state commission standards will accompany a legal review. The 2015 revised Illinois Happy Hour Law will be presented along with a detailed review of the ILETSB guidelines on conducting age compliance enforcement operations.

### Instructor

Sergeant Bruce Talbot retired in 2003, after 23 years of service with the Woodridge Police Department in Du Page County. Sergeant Talbot is an Illinois-certified law enforcement trainer with 30 years of experience, and has 20 years of experience as a contract instructor for the Illinois Liquor Control Commission and the federal Synar Grant program. He lectures at police academies across the US, as well as Northwestern University's Center for Public Safety's prestigious Traffic Institute and other national police training organizations.
