Course Description				
<p>Illinois 95<sup>th</sup> General Assembly Resolution 0051 requires <i>Manufacturer's</i> Certification on Elector-Muscular Disruption Technology (EMDT) Employed by Illinois Law Enforcement and Correctional Officers. <u>TASER International</u> requires that users of the TASER Conducted Electrical Weapon (CEW) device take a certification course prior to carrying the TASER. That certification expires one year from the date of issue.</p> <p>This 6-hour class is for the certification of the <u>TASER Conducted Energy Weapon</u>. This certification will involve a review of TASER technology and the proper and safe methods for deployment of the TASER EMD device. "Failure Drills" will be practiced and a written examination will be given, as a part of this certification process.</p>
